CONSTRUCTION ACCIDENT

Our client was a union carpenter working on a luxury high rise building in Manhattan when his accident occurred. He was 12 feet above a concrete floor securing plywood to a deck platform when the beam he was standing on twisted, causing him to fall backwards onto the concrete. The beam had not been secured by the crew that built the platform, nor was any safety railing installed. The injuries our client sustained are permanent and life altering. He endured back surgery, and will have permanent pain, loss of range of motion, weakness, and the need to use a walking aid. His injuries will affect his ability to earn a living for the remainder of his working years.

PEDESTRIAN KNOCKDOWN

Our client, a 68 year old retired machinist for 7-Up, was crossing North Ave. in New Rochelle, NY, when he was struck by the Defendant's car. Defendant driver was a 78 year old woman who wore thick glasses. She did not know that she struck the our client until after she got out of her car. Eyewitnesses said that Plaintiff was crossing against the light and outside the crosswalk. Our client suffered leg and knee fractures as well as fractured skull, which resulted in a traumatic brain injury. Our client had no memory of the accident. He was placed in a nursing home, where he lived for 2 years until he died. This case settled before trial.

CONSTRUCTION ACCIDENT

Our client was on her job as an environmental inspector at a Queens, New York bridge constructions site. A subcontractor had failed to follow industry procedure and used a makeshift device to move the containment unit that plaintiff had to navigate when doing her inspection. As she descended a ladder, a 1" metal cable broke free, hitting her in the head and causing her to fall off the ladder to a platform five feet below. Our client was diagnosed with a closed head injury and PTSD and 7 years later is still in treatment. This case settled at Mediation.

ANDREW FINKELSTEIN, ASKED TO JOIN DISTINGUISHED PANEL AT HARVARD LAW SCHOOL

MOTORCYCLE SAFETY THIS SEASON

With the warm weather having finally arrived, we are seeing more motorcycles on the road. Cars and trucks should always use caution when traveling near motorcycles. Always share the road and never tailgate.

Approximately 80% of reported motorcycle crashes result in injury or death, according to the motorcycle safety guide by the National Highway Traffic Safety Association. Motorcycle fatalities represent 5% of all highway fatalities each year.

As a motorcyclist, your chance of survival can be increased by following these simple safety tips:

- **Never Ride without a Helmet and Eye Protection:** check your helmet for the DOT logo to ensure that it complies with DOT requirements.
- **Read the Owner's Manual:** familiarize yourself with your motorcycle.
- **Attend a Motorcycle Training Course:** it is the best way to learn how to operate a motorcycle safely and skillfully.
- **Wear the Correct Shoes, Gloves & Clothing:** thick, protective attire is all that is between you and the pavement in the event of a crash. It could save your life.
- **Abide By Traffic Rules & Regulations:** the same traffic rules that apply to other motorists apply to you as a motorcyclist.
- **Ride with a Passenger with Caution:** riding with a passenger requires even more skill than riding alone.
- **Avoid Riding Between Lanes:** never ride between lanes of slow moving or stopped traffic. Never share a lane with another vehicle.
- **Be Alert at Intersections:** this is where 70% of motorcycle collisions occur. Watch for vehicles that may unexpectedly turn in front of you or pull out in front of you. Be prepared to react quickly.
- **Assume That You Are Invisible to Other Motorists:** position yourself so that you are seen. Ride in the portion of the lane where it is most likely that you will be seen by others on the road. Avoid "no-zones" or blind spots.

MAYOR BILL DE BLASIO TAKES ACTION TO IMPROVE PEDESTRIAN SAFETY IN NYC

Earlier this year, Mayor Bill de Blasio outlined a set of proposals aimed at improving the safety of our pedestrians here in NYC. His end goal: to eliminate traffic fatalities.

In the past 3 years, 683 pedestrians have been killed in traffic accidents in the NY area. The 42-page plan, known as Vision Zero, treats all traffic deaths as inherently preventable. The most significant changes involve the NYPD, whose officers will increase precinct-level enforcement of speeding. Other measures include the widening of parking lanes, to keep delivery vehicles out of travel lanes while double-parked, and the use of an automated system that would

pause a taxicab meter if a driver exceeds the speed limit.

“Our lives are literally in each other’s hands,” Mr. de Blasio said at a news conference at Public School 75 on the Upper West Side, an area where three pedestrians were killed in fewer than 10 days last month. “Our children’s lives are in each other’s hands.”

In 2013, 176 pedestrians were killed in traffic in New York, according to police statistics.

Some of the mayor’s proposals – like lowering the citywide speed limit to 25mph from 30mph

and expanding red-light and speed cameras that issue tickets – require approval from Albany.

So far this year, the Police Department has devoted increased attention to jaywalking. Jaywalking tickets issued have increased by nearly 800% already this year. Tickets issued to drivers fell slightly. However, the stronger emphasis of this program would be on increasing the enforcement of violations like failing to yield, improper turning or using a phone while driving.
