ASBESTOS: STILL A PROBLEM

Many people mistakenly believe that problems with asbestos are a thing of the past, but—unfortunately—this is not the case. Thousands of people are diagnosed with asbestos-related diseases, such as mesothelioma and lung cancer, every single year and millions more have been exposed to the toxic mineral in some fashion.

The diseases associated with asbestos exposure do not commonly appear until 30 or 40 years after the initial exposure, so most of the people diagnosed today were exposed years ago.

ASBESTOS EXPOSURE AT WORK AND AT HOME

The most common sources of asbestos exposure were job-related. If you worked in a job where asbestos was used, you may be at risk for developing mesothelioma, lung cancer, asbestosis or other diseases. Asbestos was also a regular element in a number of common household items, like joint compound and dry wall. Family members who worked with asbestos at their jobs could even bring the fibers back into the house on their clothes. If you think you've been exposed you should see a doctor right away.

SYMPTOMS OF DISEASES

Symptoms of early-stage mesothelioma or lung cancer can be easily mistaken for other, less serious illnesses. If you suffer from any coughing, shortness of breath, chest pain or sudden weight loss, see your doctor right away and tell him or her if you know you've been exposed to asbestos.

ASBESTOS CLAIMS

The law may place limits on when you can file your case, so if you have been diagnosed with an asbestos-related illness, you should speak with an attorney as soon as possible.


